**Subject: Centrally Sponsored Scheme (CSS) for development of infrastructure facilities for the judiciary - Release of Financial Assistance to the Government of National Capital Territory of Delhi for the year 2019-2020 - Regarding.**

Sir,

I am directed to convey the sanction of the President of India for the payment of Rs.46,69,00,000/- (Rupees Forty Six Crore Sixty Nine Lakh Only) during 2019-20 as financial assistance to the Government of National Capital Territory of Delhi under the Centrally Sponsored Scheme (CSS) for development of Infrastructure facilities for judiciary, for construction of court buildings and residential accommodation for Judges / Judicial officers covering District and Subordinate Courts of Delhi. The High Court is not covered under the Scheme.

2. The expenditure involved is debit to Demand No. 63 during 2019-20 under Major Head 3602 - Grants-in-aid to Union Territory- Government with Legislature, Sub Major Head 06 - Centrally Sponsored Schemes, Minor Head 06.101 - Central Assistance/Share, Sub Head 45 - Infrastructural facilities for Judiciary, Object Head 45.00.35 - Grants for Creation of Capital Assets.


3. The Government of National Capital Territory of Delhi is requested to utilize this amount during 2019-20. Priority should be given to completing the on-going projects. Funds are released for ongoing and new Projects complying with the norms and specification for the construction of court halls and residential quarters of subordinate judiciary, as per the extant Guidelines of the Scheme. The State Government may furnish the Project-wise details for the projects against which above funds are allocated and utilized. The details of amount spent by the Government of National Capital Territory of Delhi along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest.

4. The accounts of the Government of National Capital Territory of Delhi in respect of the Grants being released shall be open to inspection by the Sanctioning Authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.

5. This sanction has been entered in the Register of Grants at Serial No. 11 at page no. 21-22.

6. This issues with the concurrence of Integrated Finance Division, Legislative Department vide AS & FA's Note No 323 dated 20/09/2019 and approval of Secretary (Justice) vide Note no. 325 dated 23/09/2019 in efile no 288 (Physical file no. J-11017/11/2015-JR).
