- 3. The cheque may be drawn in favour of "Secretary, Finance, Government of Sikkim, Gangtok and sent to his official address viz. Secretary, Finance, Government of Sikkim, Manan Bhawan, Gangtok Sikkim-737101.
- 4. The State Government is requested to utilize this amount along-with the State Government's Share on the pattern of 90:10 sharing basis between Central and State Governments. Funds are released for ongoing and new Projects complying with the norms and specification for the construction of court halls and residential quarters of subordinate judiciary, as per the extant Guidelines of the Scheme. The State Government may furnish the Project-wise details for the projects against which above funds are allocated/Utilised. The details of amount spent by the State Government along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest.
- 5. The accounts of the State Government in respect of the Grants being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.
