The expenditure involved is debitable to Demand No. 64 during 2020-21 under Major Head 3601 Grants-in-aid to State Governments, Sub Major Head 06 Centrally Sponsored Schemes, Minor Head 06.101 Central Assistance/Share, Sub Head 57 Infrastructural facilities for judiciary, Detailed Head 03 Infrastructural facilities for Judiciary, Object Head 57.03.35 Grants for Creation of Capital Assets.

The accounts of the State Government in respect of the Grants being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.
