Subject: **Centrally Sponsored Scheme for development of infrastructure facilities for the judiciary – Release of Central Assistance to the Government of Nagaland for the year 2021-22**

Sir,

I am directed to convey the sanction of the President of India for the payment of **Rs. 13,27,00,000/- (Rupees Thirteen Crore Twenty Seven Lakh Only)** during 2021-22 as central assistance to the **Government of Nagaland** under the Centrally Sponsored Scheme for development of Infrastructure facilities for judiciary, for construction of court buildings and residential accommodation for judges /judicial officers covering District and Subordinate Courts. The High Courts are not covered under the revised Scheme.

2. The expenditure involved is debit to Demand No. 64 during 2021-22 under Major Head 3601 – Grants-in-aid to State Governments, Sub Major Head 06 – Centrally Sponsored Schemes, Minor Head 06.101 – Central Assistance/Share, Sub Head 57 – Infrastructural facilities for Judiciary, Detailed Head 03 –Infrastructural facilities for Judiciary, Object Head 57.03.35 – Grants for Creation of Capital Assets.

3. The State Government is requested to utilize this amount along-with the State Government's Share on the pattern of 90:10 sharing basis between Central and State Governments.. **Funds are released for ongoing and new Projects complying with the norms and specification for the construction of court halls and residential quarters of subordinate judiciary, as per the extant Guidelines of the Scheme, priority may be given to completion of ongoing projects. The State Government may furnish the Project-wise details for the projects against which above funds are allocated/Utilised.** The details of amount spent by the State Government along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest.


