Subject: Centrally Sponsored Scheme (CSS) relating to development of infrastructural facilities for the judiciary – Release of financial assistance to the Government of National Capital Territory of Delhi during 2015-2016.

Sir,

I am directed to convey the sanction of the President of India to the payment of a grant of Rs. 60,40,31,674 /- (Rs. Sixty crore forty lakh thirty one thousand six hundred and seventy four only) during 2015-16 to the Government of National Capital Territory of Delhi under the Centrally Sponsored Scheme (CSS) for construction of court buildings and residential accommodation for judges / judicial officers covering the District and subordinate Courts. The High Courts are not covered under the scheme.

2. The cheque may be drawn in favour of the Principal Secretary (Finance), Finance Department, Government of National Capital Territory of Delhi, New Delhi and sent to his official address viz. The Principal Secretary (Finance), Finance Department, Government of National Capital Territory of Delhi, 4th Level, 'A' Wing, Delhi Government Secretariat, I.P. Estate, Delhi – 110 002.

3. The expenditure involved is debitable to Demand No. 64 during 2015-16 under Major Head 3602-Grants in aid to UT Governments (with legislature), Sub Major Head 04-Grants to Centrally Sponsored Plan Scheme, Minor Head 04.891-Administration of Justice Other Grants, 01-Grants for infrastructural facilities for judiciary, 01.00.35-Grants for creation for Capital Assets.

4. The concerned State Government / UT Administration is requested to utilize this amount during the current financial year 2015-16. The details of the amount spent by the National Capital Territory of Delhi, alongwith audit certificate, utilization certificate in the prescribed format,(GFR-19A) duly signed by the competent authority and physical achievements may be sent to this Department at the earliest & latest by the end of the stipulated period in this regard.

5. The accounts of the State Government / UT Administration in respect of the Grant being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provisions of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.

6. This sanction has been entered in the Register of Grants at Sl. No. 14 at page no. 15-16.

7. This issues with the concurrence of IF Wing, Legislative Department vide their Dy. No. 1125 dated 21/12/2015.
