Subject: **Centrally Sponsored Scheme for the Development of Infrastructural Facilities for the Judiciary – Release of Central Share to the Government of Himachal Pradesh during 2016-2017.**

Sir,

I am directed to convey the sanction of the President of India to the payment of **Rs. 8,19,00,000/- (Rupees Eight crore nineteen lakh only)** during the year 2016-17 as Central share to the State Government of Himachal Pradesh under the Centrally Sponsored Scheme for development of Infrastructure facilities for judiciary, for construction of court buildings and residential accommodation for judges / judicial officers covering District and Subordinate Courts. The High Courts are not covered under the revised Scheme.

2. The expenditure involved is debitable to Demand No. 56 during 2016-17 under Major Head 3601 – Grants – in – aid to State Governments, Sub-Major Head 04 – Grants for Centrally Sponsored Plan Scheme, Minor Head 04.891-Administration of Justice Other Grants, 01-Grants for infrastructural facilities for judiciary, 01.00.35-Grants for creation of Capital Assets.

3. The State Government is requested to utilise this amount alongwith the State Government's Share on the pattern of 90:10 sharing basis between Central and State Governments. Priority should be given to completing the on-going projects. The details of the amount spent by the State Government along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest & latest by the end of the stipulated period in this regard.

4. The accounts of the State Government in respect of the Grant being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.

5. This sanction has been entered in the Register of Grants at Serial No. 13 at page No.19-20.

6. This issues with the concurrence of IF wing, Legislative Department *vide* AS & FA's Diary No. 866 dated 22.08.2016.
