- 3. The State Government is requested to utilise this amount alongwith the State Government's Share on the pattern of 60:40 sharing basis between Central and State Governments. Priority should be given to completing the on-going projects. The details of the amount spent by the State Government along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest & latest by the end of the stipulated period in this regard.
- 4. The accounts of the State Government in respect of the Grant being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.
