Subject: **Centrally Sponsored Scheme for development of infrastructure facilities for the judiciary – Release of Central Assistance to the Government of Meghalaya for the year 2018-19.**

Sir,

In continuation of this Department's order of even no. dated 10<sup>th</sup> August, 2018 sanctioning of Rs. 10,82,00,000/- (Rupees Ten Crore Eighty Two Lakh Only) to the State Government of Meghalaya, I am directed to convey the sanction of the President of India for the payment of **Rs. 4,00,00,000/- (Rupees Four Crore Only)** during 2018-19 as central assistance to the **Government of Meghalaya** under the Centrally Sponsored Scheme for development of Infrastructure facilities for judiciary, for construction of court buildings and residential accommodation for judges /judicial officers covering District and Subordinate Courts. The High Courts are not covered under the revised Scheme.

2. The expenditure involved is debitable to Demand No. 61 during 2018-19 under Major Head 3601 – Grants-in-aid to State Governments, Sub Major Head 06 – Centrally Sponsored Schemes, Minor Head 06.101 – Central Assistance/Share, Sub Head 57 – Infrastructural facilities for judiciary, Detailed Head 03 –Infrastructural facilities for judiciary, Object Head 57.03.35 – Grants for Creation of Capital Assets.

3. The State Government is requested to utilize this amount along-with the State Government's Share on the pattern of 90:10 sharing basis between Central and State Governments. **Funds are released for completion of on-going projects only. The State Government may furnish the Project-wise details for the projects against which above funds are allocated.** The details of the amount spent by the State Government of Meghalaya, along-with audit certificate, utilization certificate in the prescribed format, (GFR-19A) duly signed by the competent authority and physical achievements may be sent to this Department at the earliest latest by the end of the stipulated period in this regard.


4. State Government is required to monitor the projects of construction of court halls and residential units for Judges and Judicial Officers of District and Subordinate courts in the State and upload details of existing, completed and under construction court halls and residential units with geo-tagging on the web-portal *namely "Nyaya Vikas"*. Further, financial assistance to the State Government during the current or next financial year will be considered only after availability of information on the above mentioned Web Portal.

5. The accounts of the State Government in respect of the Grants being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.

6. This sanction has been entered in the Register of Grants at Serial No. 29 at page no. 13-14.

7. This issues with the concurrence of Additional Secretary and Financial Adviser (Law) in office file *vide* note no. #159 dated 12.10.2018 and approval of Secretary (Justice) *vide* Dy. No. 1427 dated 22.10.2018.

**Reasons:-** (a) This amount is kept under the non-functional head 2552 for the benefit of North-Eastern States and the same is released to them only after re-appropriation of the fund required to a functional head i.e. 3601-Grants-in-aid to the State Governments under the CSS Scheme.

(b) The fund under this head is kept only for the States other than the NER States and the fund is released to the NER States (Govt. of Manipur - Rs.4,00,00 Thousands, Meghalaya - Rs.4,00,00 Thousands and Nagaland - Rs.3,21,00 Thousands), after re-appropriating the same from the non-functional head 2552.

2. The above re-appropriation has been approved by the Secretary (Justice) vide Diary No.1427 dated 22.10.2018 in terms of the Ministry of Finance, Department of Expenditure's D.O. letter No. 2(66)-B(CDN)/2001 dated 12.06.2001.
