**Subject: Centrally Sponsored Scheme (CSS) for development of infrastructure facilities for the Judiciary – Sanction of Central Financial Assistance to the State Government of Jammu and Kashmir during the year 2018-2019.**

Sir,

In continuation of previous sanctions of Rs. 10,21,00,000/- (Rupees Ten Crore Twenty One Lakh Only) dated 20.07.2018 and Rs. 7,76,00,000/- (Rupees Seven Crore Seventy Six Lakh only) dated 04.02.2019 during 2018-19 to the State Government of Jammu and Kashmir, I am directed to convey the sanction of the President of India for the payment of **Rs. 1,04,00,000/- (Rupees One Crore Four Lakh Only)** during 2018-19 as central assistance to the Government of **Jammu and Kashmir** under the Centrally Sponsored Scheme for development of Infrastructure facilities for judiciary, for construction of court buildings and residential accommodation for judges / judicial officers covering District and Subordinate Courts. The High Courts are not covered under the revised Scheme.

2. The expenditure involved is debitable to Demand No. 61 during 2018-19 under Major Head 3601 – Grants-in-aid to State Governments, Sub Major Head 06 – Centrally Sponsored Schemes, Minor Head 06.101 – Central Assistance/Share, Sub Head 57 – Infrastructural facilities for judiciary, Detailed Head 03 –Infrastructural facilities for judiciary, Object Head 57.03.35 – Grants for Creation of Capital Assets.

3. The State Government is requested to utilize this amount along-with the State Government's Share on the pattern of 90:10 sharing basis between Central and State Governments. **Funds are released for completion of on-going projects. The State Government may furnish the Project-wise details for the projects against which above funds are allocated.** The details of amount spent by the State Government along-with audit certificate, utilization certificate in the prescribed format (GFR-19A) duly signed by the competent authority and physical achievements may please be sent to this Department at the earliest latest by the end of the stipulated period in this regard.

4. The accounts of the State Government in respect of the Grants being released shall be open to inspection by the Sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Account Office of the Department of Justice, whenever the State Government is called upon to do so.

5. This sanction has been entered in the Register of Grants at Serial No. 41 at page no. 15-16.

6. This issues with the concurrence of Additional Secretary and Financial Adviser (Law) in eoffice file *vide* note #129 dated 27/02/2019 and approval of Secretary (Justice) dated 05/03/2019 in electronic file / Computer file no 1161.
